Minutes of NARFE Chapter 185 Meeting September 12, 2022

President Dr. Dan Webb opened the Zoom meeting at 10:28 AM. By the end of this meeting, 10 individuals participated.

Dan introduced Tania Weaver as our guest speaker. She has worked at the Radiant Credit Union, worked as a free-lance writer and for Social Security. The general topic of her presentation related to how one should maintain saving accounts safe from illegal activities. Many scam types exist and one should monitor his/her accounts for possible intrusion and recognize attempts by others to "penetrate" your private account information.

The first scam she presented related to those winning with lottery proceeds. Scams for these monies begin by using phishing techniques from unknown individuals. A second scam used is they claim they are providing renewed technical support possibly resulting in their accessing account numbers. Scams can be initiated via phone, computer, email, etc. Do not click on suspicious emails or suspicious links in emails. Your bank, credit union, or legitimate business contacts will not ask you to participate through third parties. Doing so could compromise

your own control of your computer and accounts. Another scam can come from an unknown person contacting you about your income tax. Some have used arrest threats as a way to get people "to bite." Should you have a real issue with the IRS, they will contact you with their formal letter heads, etc. They will not have you wire funds.

Overall, to keep safe from scams, use secure passwords that you, not others, can relate to. It is best to use multifactor authentication within passwords. Always check your monthly statements for suspicious intrusions. If you are a victim, freeze that account immediately. Stop using your computer if it becomes compromised. Get professional advice on how to solve these problems. One may have to file a police or identity report or deal with the Federal Trade Commission.

She warned us to be aware of "dumpster divers". They access your trash, mailbox, etc.

Dan began the business portion of the meeting at 10:49 AM. He led us in the pledge of allegiance followed by a moment of silence.

Vice President, Sharon Papciak, informed us that our guest speakers next month will be from Blue Cross/Blue Shield (BC/BS), and Aetna insurance companies. Premium costs for BC/BS will increase by 8% next year. Basic coverage will be \$43/month. Aetna will be providing some sort of return dollar program to the federal government. She then indicated that our December meeting will be on December 12, 2022 and will be a dinner of some sort. By December 7, 2022, she will need have the exact number of participants for that meal meeting. Linda Cook and Joy Joy Jordon will be making the arrangements related to the December meal meeting.

Dan suggested that by December 1, 2022 is when we should make our participation commitments for the meal. It may be held at the youth building on the premises of Trinity United Methodist Church. He said we need to have at least 15 individuals for that meal meeting. Possibly the cost for the meals for members will come from our Chapter 185 budget because we have adequate funds to cover such. Cost for friends/guests will be \$10 should be covered by related members.

Dan called for approval of the minutes for the September Chapter 185 meeting and such was done. Also, Linda Cook summarized her assembly of the most recent budget which was combined for both August and September. Dan suggested that maybe we could give more to Alzheimer's, i.e. \$500 to \$1,000 because we have adequate money in savings and checking accounts. He has mentioned that idea in previous meetings.

Dan adjourned the meeting at 11:21 AM.

Alzheimer's and High Blood Pressure - What's the Connection?

"High blood pressure is tricky because it often doesn't cause any symptoms. And while the biggest threat may be to your heart, surprising new findings show your brain health is at risk, too. This is the case even if you only have slightly higher blood pressure.

A study published in the JAMA – which included findings from 12 studies involving more than 92,000 people – found even slightly higher blood pressure is linked to a **30% higher risk of dementia** two decades later. Dr. Steven Greenberg, professor of neurology, Harvard Medical School said, 'This study underscores the thinking that lowering blood pressure is likely to be an effective way to prevent cognitive impairment.' Cognitive impairment is often a precursor to dementia."
