The NARFE NEWSLINE stated the GPO/WEP has new sponsors and is not dead. The Windfall Elimination Provision and Government Pension Offset has been <u>reintroduced</u>. The bill was submitted by Rep. Gravies (R-LA) a new lead sponsor than in previous sessions and in joined by Rep. Spanberger (D-VA), marking this bill as a bipartisan effort. Of note, the legislation retained its bill number from the previous Congress, still listed as H.R. 82.

ALZHEIMER'S UPDATE Bill Fleming

New Drug Promises to Slow Alzheimer's

The FDA has given an early approval to the drug lecanemab, brand name Leqembi developed by Eisai Co. and Biogen Inc. The drug should be **used by patients with early stage Alzheimer's.** It reduces levels of a protein called amyloid from patients with early stage Alzheimer's and **can delay the disease progression** by about 5 months.

Leqembi requires infusions given twice monthly at a clinic or hospital. To qualify a patient must have significant levels of amyloid in their brain. Side effects include brain bleeds (in 17.3% of study patients)



and brain swelling (in 12.6% of study patients). These **side effects are manageable** with proper monitoring. Bleeding or swelling can be detected by MRI scans. Treatment can be paused until the patient recovers. Patients taking blood thinners run a high risk of bleeding.

Patients should receive an MRI before starting



treatment with Leqembi and intermittently over the first several months of treatment to check for side effects.

The drug will be **commercially available by January 23.** A fair price for the drug will be in the range of \$8,500 to \$20,600 a year. **Medicare reimbursement** will not be in place until **the end** of 2023.
