Jody began her program by asking all of us "how much does our brain weigh?" We had many different answers. My answer of 15 pounds was way off!! It seems a normal brain weighs about 3 pounds and is about 75% water. Well those two figures certainly explains a lot. Also, many diseases and brain injuries can cause the brain to shrink.

It seems that over 6 million people in the United States suffer from Alzheimer's disease. There are 580,000 here in Florida and 17,611 right here in Polk County alone. Alzheimer's is progressing at an alarming rate all over the world.

The good news is that there are now 2 new treatments for Alzheimer's that have been approved by the FDA. If you are concerned about your brain health you need to ask your doctor to recommend you for an Alzheimer's memory screening. There are bio-markers that can alert you to possible tendencies for Alzheimer's disease. There is a 24/7 Alzheimer's help line with qualified people to answer any questions you may have. Call 1-800-272-3900. If you would like to volunteer to participate in programs that help scientists learn more about this disease, go on line to: volunteer.alz.org. Several of our chapter members have participated in the past and we have some participating now.

Jody also spoke about the stress on caregivers of Alzheimer's patients. Hopefully, one day, this disease can be eradicated.

Dues Withholding Incentive

Currently a little over half of our chapter members are taking advantage of NARFE's Dues Withholding Program. I urge all of you to take advantage of this program. You can have your NARFE dues, as well as your spouse's dues, withheld from your annuity. The program saves you money and you will no longer receive those yearly renewal notices. National dues are currently \$48.00 per year plus \$11.00 Chapter dues for a total of \$59.00. Under the Dues Withholding program the National dues rate is \$42.00 per year plus \$11.00 chapter dues which is a total of \$53 00 a savings of \$6.00 per year. Divide that by 12 and your monthly dues rate is \$4.42 a small price to pay to protect your hard-earned benefits and receive the many benefits that NARFE offers.

You don't have to wait until your dues renewal date to sign up for dues withholding. You can sign up at any time and it will go into effect at your next renewal date.

To encourage you to take advantage of this great program anyone who signs up for Dues Withholding through the end of this year the Chapter will pay for your first year's dues saving you another \$53.00 up-front. When the chapter receives notification that you have taken advantage of this offer the Chapter will send you a check for \$53.00. Don't delay, this offer is only valid through the end of December.

NARFE also benefits from members who are on dues withholding. Membership retention is greatly enhanced, and the cost of mailing the renewal notices is eliminated, therefore saving NARFE a considerable amount of money each year, money that can be used to support NARFE's mission.
